

Grant Brusegard Memorial Entrance Bursary 2020 Application



Purpose of Award:

Grant Brusegard (1957-2014) lived life believing when one was helped, it honoured the benefactor to pass it along. Throughout his life, Grant dealt with difficult circumstances and at pivotal times, opportunities arose to convert these. He lived a life of sobriety, compassion and humour. He worked as a logger, in construction, and as a mature student. He later went onto a thirty-year career in nursing. He felt education was a ticket to a larger world. Those who loved him wish to carry on his generosity and present this award in his name.

Eligibility:

Awarded to a full-time student in any program at the Merritt campus who is registered in a minimum 60% course load, who attends regularly, achieves strong grades and demonstrates financial need. The student must be from the Lytton, BC area. If a recipient cannot be found, preference will be given to students from the Southern Interior of BC. The NVIT Awards Adjudication Committee will determine the recipient.

Late or incomplete applications will not be accepted. Please mail or drop off original copies only; faxes, emails and/or photocopies will not be accepted.
