Discussion: To align the program with the national accreditation body, ICBOC, the CHAD program is revising the program to include a focus on mental health and wellness. This is also the rationale for the name change to Indigenous Holistic Wellness and Addictions (IHWA). Council questioned the program's rationale for not including a criminal record check from students given the practicum requirement. ICBOC does not require a criminal record check because it acknowledges that many students have "lived experience" and views that as an asset for working in the field. Leadership will confirm with risk management the implications of not requiring a criminal record check for student entering the practicum setting and will update membership when confirmed.
