Mr. Butler reported that there are insufficient funds within the Ministry to support all PS institutes. The Ministry did not receive any funding from the Federal Government this year. 13 out of 25 PS institutes were in a deficit position last year. NVIT is the only PS Institute to receive year-end funding this year. The Ministry appreciates the unique position and mandate of NVIT that does not include international students in the funding model. The Ministry also appreciates that NVIT's funding structure is different & didn't experience the challenges other institutions faced during the pandemic due to the decrease in international students.

The Board expressed concern that every year NVIT has to beg for additional funding. We need a level of predictability and certainty every year and a long-term solution. NVIT is underfunded for the amount of FTE's produced.

The Board is aware of the funding review & how NVIT's FTEs rank with the Northern institutions.

Is there anything Management or the Board can do to bump NVIT's funding challenges up the priority list?

Mr. Butler indicated that there is nothing NVIT can do and there will be no solution until after the next election. It is not necessary to elevate the issue because it's already being discussed within the Ministry and NVIT remains a priority.

Mr. Butler will continue to advocate for NVIT within the Ministry. Jason logged off at 4:37pm.
