

## Shyanne-Lee Clarke Inclusive Post-Secondary Education Tuition Waiver Application

In recognition of Shyanne-Lee Clarke and in partnership with STEPS Forward, NVIT is committed to the implementation of the Shyanne-Lee Clarke Inclusive Post-Secondary Education Tuition Waiver. This Tuition Waiver is open to both current and prospective NVIT students enrolled through the Inclusive Post-Secondary Education partnership with STEPS Forward, across all programs/courses delivered at the NVIT Merritt Campus.

STEPS Forward is based on the premises:

- 1. Everyone has the desire and ability to learn. Eligibility therefore, is open to anyone with a developmental disability who wants to learn, regardless of level of cognitive capability, or any other disability related support requirements.
- 2. These individuals desire to pursue an education that is coherent with that of any student in a typical vocational, college, or university program; that is in the same classes and in the same ways.
- 3. Students, and their families/advocates, want to use this experience as a foundation to build an inclusive life.

STEPS Forward facilitators provide the inclusion support required for the student to learn, engage in campus activities, complete course material, and find employment. As non-crediting students, they complete academic work to the level of their ability leading to a Certificate of Completion issued by their post-secondary educational institution.

#### In addition to the above, current and prospective STEPS Forward learners may be eligible if they meet the following criteria:

- Selected as a prospective recipient by the STEPS Forward Coordinator
- Submit a complete and signed Application for the Shyanne-Lee Clarke Inclusive Post-Secondary Education Tuition Waiver and an Authorization for Release of Information to the Enrolment Services Office;
- Be at least 19 years of age during the academic year of study;
- Have an offer of admission to NVIT and confirmation of STEPS Forward support for the upcoming semester in a program leading to a Certificate of Completion OR be a continuing NVIT student, receiving support for STEPS Forward, registered in a program leading to a Certificate of Completion;
- Students will enroll in a minimum of two courses a semester in the program of study that they choose. Student responsibilities include:
  - Attending lectures, tutorials and labs
  - Completing modified exams and assignments
  - Meeting with inclusion facilitators to discuss each course
- Students are enrolled in courses as participatory auditors, this allows professors and inclusion facilitators to modify course work as much or as little as needed for the student to engage with the course. At the end of their course of study, students receive a Certificate of Completion and attend convocation with their department of study. Please note: The Registrar's Office will review the eligibility of continuing students at the end of each semester and will notify the students. Continuing Tuition Waiver recipients do not need to apply each semester.

### Terms of the Shyanne-Lee Clarke Inclusive Post-Secondary Education Tuition Waiver include, but may not be limited to, the following:

- The waiver is not applicable to tuition for Community Education or Continuing Studies courses;
- The waiver applies only to the tuition fees for the course; any other expenses necessary for participation in the course such as books, supplies, Student Society fees, lab fees, UPASS BC fees, theatre tickets, equipment rental, etc., must be paid by the student;
- As a minimum number of tuition-paying students are required in each course to enable it to be offered, NVIT reserves the right to limit the number of waivers to three (3) STEPS Forward students per semester;
- All refunds are subject to the Refund of Fees Policy C.3.12.

If approved, NVIT will contact you or your STEPS Forward Inclusive Facilitator to confirm your eligibility and details of funding. NVIT reserves the right to change criteria based on funding availability.
